



# LEGISLATIVE "PIE" DAY DISPLAY APPLICATION

February 14, 2018

Deadline: Postmarked by November 15, 2017

## DISPLAY BOARD REQUIREMENTS:

Size & color: 48 x 36-inch tri-fold display board. Back: solid white, black, or blue. No extensions added.

Placement: 6 ft. table with a white tablecloth per display is provided.

## DISPLAY BOARD FORMAT: simple messages *delivered at a glance*

1. Standing 10 feet from the display, scan it for 5 seconds.
  - a. What message concerning home education is conveyed?
  - b. What does the average person viewing learn about your topic?
  - c. How is the viewer favorably impressed?
  - d. Is the wording concise, large, and understandable to someone unfamiliar with home education?
2. Title size: 3 inches minimum. 5 words maximum.
3. Caption size: easy to scan from 10 feet. 1 1/2" font recommended. Use large, concise captions.
4. Picture dimensions (in inches): 5x7 or 8x10.
5. Bring additional visual aids to place on your table. Most legislators have only a few moments to pass through. Others who attend may have the opportunity to look over all of your materials.

## DISPLAY ATTENDANTS: *displays must be attended by an adult at all times*

Student must be 10 years old or above, privately home educating, and able to remain at the display for the full five hours. Family must be current ICHE members on the day of the event. For dress and conduct protocols refer to "Legislative Day Information." To be considered, **ICHE Consent & Authorization Form is required for all adult, minor child, and adult child participants with application.**
