PARTICIPATION: Music applicants must be 10 to 18 years old, privately home educating, and *current ICHE members*. Musicians will be representing only private home education to our legislators. Students who have studied violin, viola, cello, piano, harp, classical guitar, oboe, flute, English horn or clarinet for 2 years or more are invited to apply. In keeping with building noise protocols, amplified or loud instruments are not included. Participation is based on audition. Wear your performance attire to auditions. **ICHE Consent & Authorization Form is required for all adult, minor child, and adult child participants with application.**

COMPOSITIONS: Classical selections suitable as *background music* at a formal reception are required. To facilitate the goal of interaction with our elected officials, *virtuoso, fortissimo, or presto* compositions that will dominate or interfere with conversation and displays are not included. Solos with piano accompaniment are most common, however, ensembles limited to two instruments provide variety and are welcome.

ATTIRE: Please wear formal attire for your performance. Ladies: black floor length dresses or skirts; black blouses or dresses with sleeves; stockings; black dress shoes. No hats, pants, or leggings. Gentlemen: black slacks, shoes, socks, and tie; white, long-sleeved dress shirt. Black jacket is optional. No hats, tennis shoes, or jeans. Musicians will exit the Statehouse with instruments and equipment at the conclusion of their performance.
